Summary

This white paper discusses how the researcher proposes to determine the need for rethinking library best practices and exposing students to 21st century educational models that can help undergraduates make better use of library resources and aid in the research process.

Background/Problem: An investigation will be done on the enhancement and availability of library services to undergraduate students through the use of educational technology such as the MOODLE course management system (CMS). The target audience will be undergraduate students aged eighteen (18) to thirty-five (35). SQ2: What strategies can be used to incorporate research or library resources into course materials and the MOODLE course website?

SQ3: What Web 2.0 tools or mobile devices are useful for undergraduate learning?

2) Promotion and provision of library resources in course management systems to distance education students

3) Improving undergraduate research skills (for on campus and distance education students)

4) Strengthening digital learning, research and literacies using Web 2.0 tools

This initiative will target non-affluent public school students coming from depressed communities such as the Bain & Grant's Town constituency.

Project Method: The project if successful will creatively reverse the decline of voluntary reading among these adolescents and teach them skills for improving their general knowledge. It will also assist with introducing such students to digital skills which creates the avenue for building 21st century skills outside the formal classroom environment.

Project Objective: To help public school students improve their reading and digital skills—which may advance their education and college readiness, improve occupational outlook and increase their interests in the arts/sciences.

Project Mission: The project's mission is geared towards building life skills to promote the nation's public school students to lead safe, healthy, productive and fulfilling lives.

Dear Mrs. Bowler,

I am writing to ask whether the Bahamas Library Services would be interested in receiving a proposal for an adolescent literacy programme for less affluent public school students. As you may know, some schools and libraries are experiencing declines in recreational and voluntary reading among the New Providence student population. The Department of Statistics indicates that lack of English language skills is the major barrier to employment in our area.

The Kindle Recreational Reading Programme is intended to provide to at least thirty students with opportunities to improve their reading/literacy skills through recreational reading and will also allow them to be exposed to using current technology such as the Amazon Kindle.

As a trained literacy tutor, I will offer my skills and services to students through two-hour reading club activities and meetings, twice a week for 40 weeks. The club will be limited to thirty students whom I will break into two groups. As project director, I will assess students' abilities and interests and will work with each group for two hours on a second and third day each week, helping each student prepare for improved and advanced reading levels. All meetings will emphasize 21st century reading skills.

The total cost for the programme is \$8,000. If the Bahamas Library Services were to accept a formal proposal, we would request \$5,000 of this cost. I am awaiting a commitment from UNESCO in the amount of \$3,000 and have begun to prepare a proposal to Bahamas Library Services for the balance; I understand that a request for proposals will be issued in about two months and that grants are expected to be in the \$5,000 to \$10,000 range.

I am very excited about the benefits this programme can provide to our public student population—especially those who come from less affluent families and depressed communities.
